TRANSFER OF FUNDS – FEASIBILITY STUDY

HIS HONOR, MAYOR SULLIVAN HAS SUBMITTED TO THE BRAINTREE TOWN COUNCIL A REQUEST FOR TRANSFER OF FUNDS FOR FEASEBILITY STUDY.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BRAINTREE THAT THE TOWN OF BRAINTREE APPROPRIATE BY TRANSFERRING THE SUM OF \$45,000 FROM THE SCHOOL BUILDING RENTAL/TUITION FUND FOR THE PURPOSE OF FUNDING A FEASIBILITY STUDY RELATED TO REMODELING, RECONSTRUCTING, AND REPAIRING SOUTH MIDDLE SCHOOL, LOCATED AT 232 PEACH STREET, INCLUDING THE REPLACEMENT OF WINDOWS, UPGRADING THE HEATING, VENTILATION AND AIR CONDITIONING SYSTEMS, THE INSTALLATION OF NEW ELECTRICAL FEEDS AND CONTROLS RELATED THERETO, REPLACING THE BOILER, AND INSTALLING NEW CEILINGS IN THE HALLWAYS AND CLASSROOMS, SAID SUM TO BE EXPENDED UNDER THE DIRECTION OF THE SCHOOL BUILDING COMMITTEE; THAT THE TOWN OF BRAINTREE ACKNOWLEDGES THAT THE MASSACHUSETTS SCHOOL BUILDING AUTHORITY (“MSBA”) GRANT PROGRAM IS A NON-ENTITLEMENT, DISCRETIONARY PROGRAM BASED ON NEED, AS DETERMINED BY THE MBSA AND ANY COSTS THE TOWN OF BRAINTREE INCURS IN EXCESS OF ANY GRANT APPROVED BY AND RECEIVED FROM THE MSBA SHALL BE THE SOLE RESPONSIBILITY OF THE TOWN OF BRAINTREE.


