PETITION OF NATIONAL GRID FOR GAS MAIN LOCATIONS

The National Grid hereby respectfully request your consent to the locations of mains as hereinafter described for the transmission and distribution of gas in and under the following public streets, lanes, highways, and places of the Town of Braintree and the pipes, valves, governors, manholes and other structures, fixtures and appurtenances designed or intended to protect or operate said mains and accomplish the objects of said Company; and the digging up and opening the ground to lay or place same:

To install and maintain approximately 1,055 feet, more or less of 8 inch gas main in Commercial Street, Braintree.


From the existing 8 inch gas main at Adams Street Southeasterly to the existing 6 inch gas main at McCusker Drive, Braintree. All of which to replace and abandon the existing 6 inch gas main in Commercial Street, Braintree. Note: Connect to the existing 6 inch gas main for railroad crossing at Front Street, Braintree.

Petition #09-021 was unanimously approved by Council with the following conditions:

- A. Verbal approval to begin the **Commercial Street** gas main replacement was given by our DPW Director to keep National Grid installers out of the way of our "Commercial Street and Others Reconstruction" project. **Within the limits of the reconstruction, the main replacement can be approved with our "standard" specifications. Outside of the reconstruction limits, the pavement is already in very good condition, and so the trenches must be saw-cut and repaired with 4 inches (minimum) of hot mix asphalt followed by infrared treatment.**
