The National Grid hereby respectfully request your consent to the locations of mains as hereinafter described for the transmission and distribution of gas in and under the following public streets, lanes, highways, and places of the Town of Braintree and the pipes, valves, governors, manholes and other structures, fixtures and appurtenances designed or intended to protect or operate said mains and accomplish the objects of said Company; and the digging up and opening the ground to lay or place same:

To install and maintain approximately 500 feet, more or less of 2 inch gas main in Massachusetts Avenue, Braintree.

From the existing 3 inch gas main at Washington Street and Massachusetts Avenue Southerly to No. 38 Massachusetts Avenue. All of which to replace and abandon the existing 2 inch gas main in Massachusetts Avenue, Braintree.

Petition #09-037 was unanimously approved by Council with the following conditions:

<u>09-037</u> **– Massachusetts Avenue** was just a quick overlay, so that replacement **may be approved with our "standard" repair specifications** and that the roadway be restored to its present acceptable condition

The start of the replacement is in Washington Street (Route 37) in a section that is State Highway, and will require an MHD permit as well.
